Item position in the agenda of the associated meeting

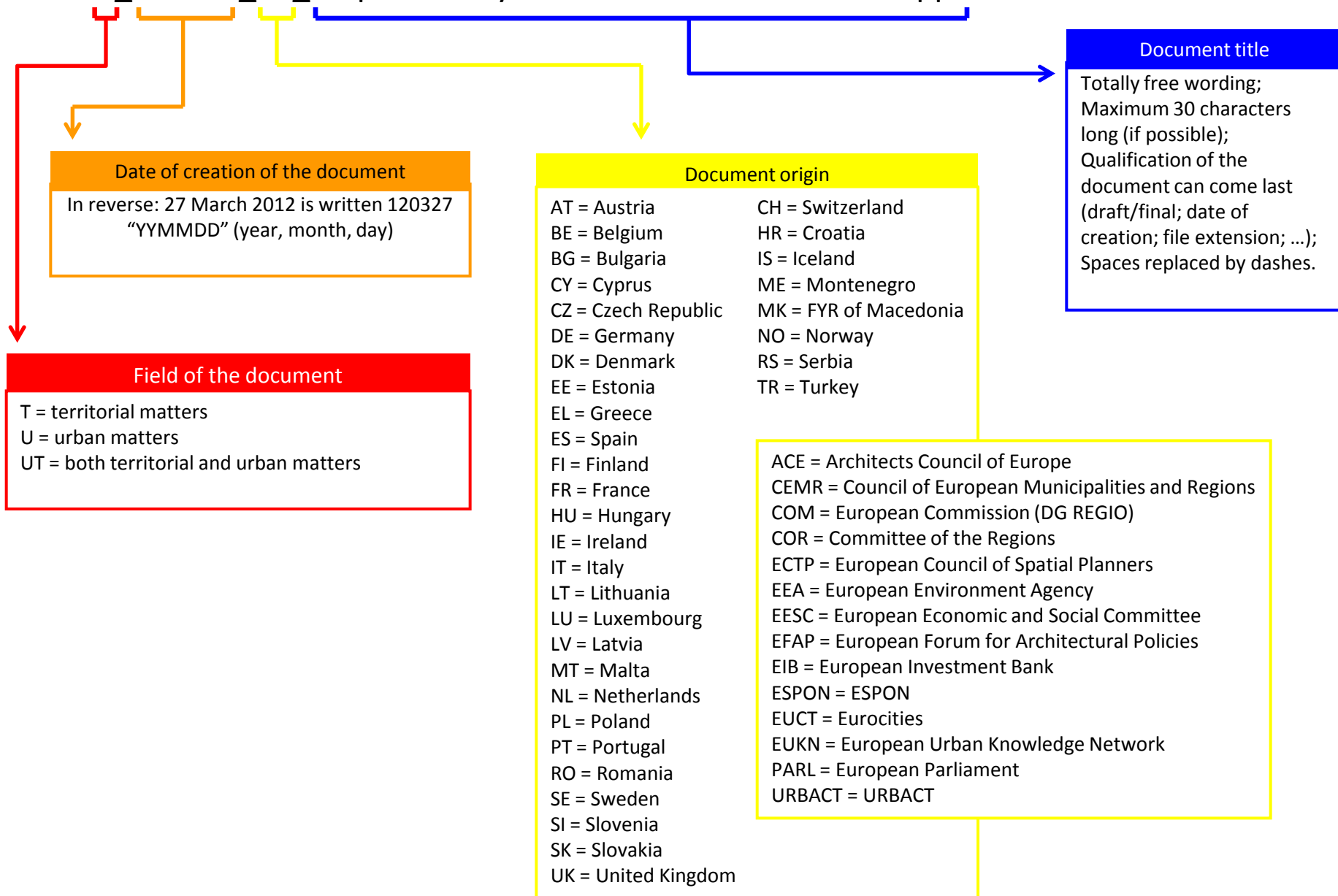
Proposition for easier retrieving:
